



**MEMORANDUM OF AGREEMENT

In consideration of the wish of the and Faculty of Adab and Humanities, Ar-Raniry State Islamic University and to establish cooperation within the framework of the academic activities with the aim of promoting cooperation in research and student internships.

This agreement entered into by and between:

Dayah Tgk Chiek Awe Geutah (hereinafter “**DTCAG**”), located at Awe Geutah, Peusangan Siblah Krueng, Kabupaten Bireuen, Aceh 24356. Indonesia, is an independent Education Institution established in 1693 represented herein by its Director, Muhsin Hasan and shall include its lawful representatives and permitted assigns of the first party.

and

Faculty of Adab and Humanities, Ar-Raniry State Islamic University (hereinafter “**FAH-UINAR**”) located at Jl. Syeikh Abdul Rauf, Darussalam, 23111, Banda Aceh, Indonesia is a Public Higher Education Institution established in 1963 represented herein by its Dean, Dr. Fauzi Ismail, M.Si and shall include its lawful representatives and permitted assigns of the second party.

Whereas: Parties agree to cooperate on programs based on equality and reciprocity;

Whereas: Pursuant to prevailing laws and regulations, as well as the procedures and policy of the government of Indonesia concerning collaboration on academic, internships, and research cooperation;

Therefore, in consideration of the above, the Parties have decided to enter into a Memorandum of Agreement (MoA) which, from the date of its signature.

Parties agree as follows:

**Article One
Objective**

The objective of the collaboration between Dayah Tgk Chiek Awe Geutah and Faculty of Adab and Humanities, Ar-Raniry State Islamic University to promote mutual academic cooperation in research and student internships between two institutions

Article Two

Areas of Collaboration

The two institutions will jointly develop some or all of the following activities based on their respective academic and student internships needs:

- a) Academic activities;
- b) Education;
- c) Research;
- d) Any other activities to be decided on the basis of mutual agreement by both institutions.

Article Three

Methods of Cooperation

The implementation of each joint activity set out in this memorandum of agreement shall be separately negotiated and determined by both institutions. Details of the implementation shall be set forth in a contract to be signed at the appropriate time by the Director of Dayah Tgk Chiek Awe Geutah and the Dean of Faculty of Adab and Humanities, Ar-Raniry State Islamic University.

Article Four

Financial Provision

The terms and necessary budget for each program and project will be described in separate documents, which will be prepared subsequent to this Memorandum of Agreement and Letters of Agreement will be signed by both parties prior to the initiation of a cooperative program or project. A program may include one or more projects.

Article Five

Non-Binding Document

- a) This MoA is not intended to be legally binding document. It is meant to describe the nature and to suggest the guidelines of the cooperation between the Parties as described above.
- b) Nothing shall diminish the full autonomy of either party nor will any constraints or financial obligations be imposed by either upon the other in carrying out the memorandum of Agreement.

Article Six

Termination

- a) The two institutions shall keep copies of the memorandum of agreement. This memorandum of agreement becomes effective upon completion of the signatures from the date of signing.
- b) This memorandum of agreement is subject to revision or renewal by mutual agreement.


