



MEMORANDUM OF AGREEMENT

BETWEEN

FACULTY OF SCIENCE AND TECHNOLOGY

UNIVERSITAS ISLAM NEGERI (UIN) AR-RANIRY BANDA ACEH

AND

WADHWANI OPERATING FOUNDATION

PREAMBLE

This Memorandum of Agreement ("MoA") is entered into on this Thursday of February 13, 2025, (13-02-2025), by and between:

1. Faculty of Science and Technology, Universitas Islam Negeri (UIN) Ar-Raniry Banda Aceh, having its principal office at Jl. Syech Abdurrauf, KOPELMA Darussalam, Kec. Syiah Kuala, Kota Banda Aceh, Indonesia (hereinafter referred to as "FST UIN Ar-Raniry"); and
2. Wadhwani Operating Foundation, a California nonprofit public benefit corporation with its office at Four Main Street, Suite 210, Los Altos, CA 94022, USA (hereinafter referred to as "Wadhwani Foundation").

WHEREAS:

1. Wadhwani Foundation aims to promote entrepreneurship, skill development, and innovation through world-class curricula, content, and methodologies (hereinafter referred to as "Wadhwani Curricula, Content, and Methodology").
2. FST UIN Ar-Raniry is committed to fostering entrepreneurship, research, and skill-based education among students and faculty members.
3. Both parties, under the existing Memorandum of Understanding (MoU) signed on 13 February 2025, have agreed to collaborate in implementing programs that align with their respective missions and objectives.

NOW, THEREFORE, in consideration of the mutual covenants and agreements contained herein, the parties agree as follows:

ARTICLE 1 – PURPOSE

This MoA outlines the specific roles, responsibilities, and commitments of both parties in implementing the entrepreneurship and skill development programs at FST UIN Ar-Raniry as per the objectives set forth in the MoU.

ARTICLE 2 - SCOPE OF COLLABORATION

1. Entrepreneurship Development Programs
 - Implement the "Wadhwani Entrepreneur" (WE) course for students and faculty.
 - Provide entrepreneurial skill-building workshops and training.
 - Support student-led startup projects through structured incubation and mentorship programs.
2. Faculty Training and Capacity Building
 - Train faculty members as facilitators for entrepreneurship courses.
 - Provide access to Wadhwani Foundation's digital learning platforms and LMS.
 - Conduct capacity-building programs for educators in entrepreneurial curriculum delivery.
3. Infrastructure and Resource Support
 - FST UIN Ar-Raniry shall provide necessary classroom infrastructure, including high-speed internet, laptops, and other required equipment.
 - Wadhwani Foundation shall provide online learning tools, digital resources, and expert mentoring support.

ARTICLE 3 - ROLES AND RESPONSIBILITIES

Wadhwani Foundation:

1. Provide access to the Wadhwani Curricula, Content, and Methodology for entrepreneurship education.
2. Conduct training sessions for faculty members on course delivery.
3. Organize masterclasses, mentoring, and industry networking for students.
4. Monitor and evaluate program effectiveness through periodic assessments and feedback mechanisms.
5. Ensure compliance with Intellectual Property Rights (IPR) and Data Protection as per the MoU.

FST UIN Ar-Raniry:

1. Implement the WE course and integrate it into relevant academic programs.
2. Nominate faculty members and students for entrepreneurship training.
3. Provide necessary logistical and administrative support for program execution
4. Facilitate student engagement through startup incubators and networking event
5. Ensure compliance with program requirements, assessments, and periodic reporting.

ARTICLE 4 - FINANCIAL TERMS

1. Both parties shall bear their respective costs for fulfilling their roles and responsibilities under this MoA.
2. Wadhwani Foundation shall provide the curricula and digital learning resources free of charge.



3. FST UIN Ar-Raniry may recover expenses related to faculty training and IT infrastructure from students but shall not charge for access to Wadhwani Foundation resources without prior written consent.

ARTICLE 5 - DURATION AND TERMINATION

1. This MoA shall be effective from the date of signing and remain in force until 12 February 2028, unless extended or terminated by mutual agreement.
2. Either party may terminate this MoA by providing sixty (60) days' prior written notice.
3. In case of breach of obligations, the affected party may issue a written notice for rectification within thirty (30) days, failing which the MoA may be terminated.

ARTICLE 6 - DISPUTE RESOLUTION

1. Any dispute arising from this MoA shall first be resolved through amicable consultation between the parties.
2. If unresolved, disputes shall be settled through arbitration in Jakarta, as per Indonesian arbitration laws.
3. The decision of the arbitration panel shall be final and binding on both parties.

ARTICLE 7 - MISCELLANEOUS PROVISIONS

1. Confidentiality: Both parties shall protect confidential information shared under this MoA and shall not disclose it to third parties without prior written consent.
2. Intellectual Property: Each party retains rights to their respective intellectual property, and any jointly developed intellectual property shall be agreed upon separately.
3. Amendments: This MoA may be amended only through mutual agreement in writing.
4. Governing Law: This MoA shall be governed by and interpreted in accordance with the laws of Indonesia.
5. Non-Exclusivity: This agreement does not restrict either party from entering into similar agreements with other institutions.
