

ACADEMIC AND RESEARCH COLLABORATION

Today Monday, date 3, month October, year 2022, at Banda Aceh, the undersigned below:

1.	Prof. Eka Srimulyani, M.A., Ph.D	Director of PASCASARJANA UNIVERSITAS ISLAM NEGERI (UIN) AR-RANIRY BANDA ACEH, located in Darussalam, Banda Aceh, Aceh, hereafter refer to the first party.
2.	Dr. Cut Dewi, M.T., M.Sc	Director of INTERNATIONAL CENTRE FOR ACEH AND INDIAN OCEAN STUDIES (ICAIOS), located in Darussalam, Banda Aceh, Aceh, hereafter refer to the second party.

The two parties agree on the following items:

- a. that the FIRST PARTY is a Pascasarjana Universitas Islam Negeri Ar-Raniry Banda Aceh, in charge of coordinating and implementing the *Tridarma* of Higher Education in the field of education, research, and community service.
- that the SECOND PARTY is a International Centre for Aceh and Indian Ocean Studies (ICAIOS) which is responsible for organizing and implementing Research and Education.

The Parties are desirous of entering into this MoU to declare their respective intentions and to establish a basis of co-operation and collaboration between the Parties upon the terms as contained herein:

ARTICLE 1

OBJECTIVES

Enhance cooperation in the domains of Education, Teaching, and Research by THE PARTIES. This partnership is part of the endeavor to accomplish the Sustainable Development Goals (SDGs), which include Quality Education, Decent Employment and Economic Growth, and Partnerships for the Goals

ARTICLE 2

SCOPE AND ACTIVITIES

The scope of collaboration on academic and education shall include but not limited the following catagories:

- 1. Collaborate in the areas of Education, Teaching, Research, and Community Service;
- 2. Collaborate in strengthening the competency of Human Resources exchange of scholars in the course of academic development.
- 3. Exchange of scientific materials that is available by both parties.
- 4. Research of interest to both parties.
- 5. Book writing, seminar, workshop, and other scientific meeting on matters of mutual interest.
- 6. Exchange of students in various activities.
- 7. Any other cooperation that mutually agreed upon by the parties.

ARTICLE 3

PLAN OF OPERATION

A detailed description of the scope of activities shall be defined ni a plan of operation, which shall be formulated following discussion and consultation among relevant staffs in Pascasarjana Universitas Islam Negeri (UIN) Ar-Raniry and International Centre for Aceh and Indian Ocean Studies (ICAIOS).

ARTICLE 4

FUNDING

The realization of activities related to the Memorandum of Understanding depends on the availability of funds, which should be sought established sources provided for such activities by each parties.

ARTICLE 5

INTELECTUAL PROPERTY RIGHT AND PUBLICATION

Each party shall continue of remain the sole owner of material ti contributes to any joint project. The parties will work together to negotiate any appropriate licensing terms. The parties will seek opportunities for the co-publications will mention this cooperation between the parties

ARTICLE 6

SETTLEMENT OF DIFFERENCES

Any differing view points and the interpretation of this Memorandum of Understanding shall be settled amicably upon mutual consultation and negotiation.

ARTICLE 6

AMANDEMENTS, DURATION, AND TERMINATION

1. Amendment to this Memorandum of Understanding can only be made afterconsultation and in writing by mutual consent between two parties.

This Memorandum of Understanding shall be effected from the date of signing and be valid
for the duration of five years from that date and will be automatically renewed on an annual
basis thereafter unless terminated or replace with another Memorandum of
Understanding.

3. Either party may terminate this Memorandum of Understanding by written notice at least six month in advance. In case the Memorandum of Understanding ceases to be in effect on account of termination, there of the provision of the plan (s) of operation shall continue to apply to the extent necessary to secure the implementation to exiting activities as agreed upon in the plan (s) of operation.
